# MOTION FOR RELEASE OF CERTAIN EXHIBITS FILED BY THE FINANCE COMMITTEE AND THE CLAIMANTS' ADVISORY COMMITTEE AND DOW CORNING CORPORATION

#### I. INTRODUCTION

The Finance Committee filed the Recommendation and Motion for Authorization to Make Second Priority Payments with this Court on December 30, 2016. It was attached by Exhibit B, the IA Report, but filed as "Restricted". It cannot be accessible through <a href="https://www.pacer.gov">www.pacer.gov</a>.

The Claimants' Advisory Committee filed the Response to the Finance Committee's Recommendation and Motion for Authorization to Make Second Priority Payments on February 10, 2017. It was attached by Exhibit 5(Summary of Monthly Department Reporting Issued by the SF-DCT), 6(Final Report of the Claims Administrator of the RSP), 7(the IA's DCT Liability Model June 2016 Data Extract), 8(Ankura Response to the CAC's Questions dated November 4, 2016) and 9(Declaration of Mark Peterson), but filed as "Restricted". Those cannot be accessible through <a href="https://www.pacer.gov">www.pacer.gov</a>. This Court issued the Order Sealing those Exhibits.

The Dow Corning Corporation and the Debtors' Representatives filed the Opposition to the Finance Committee's Recommendation and Motion for Authorization to Make Second Priority Payments on February 10, 2017. It was attached by Exhibits A(Settlement Facility-Dow Coring Trust Claims Processing Report for the Period Ending June 30, 2016) and B(Ankura Response to Questions for IA on Final Report), but field as "Restricted". Those cannot be accessible through <a href="https://www.pacer.gov">www.pacer.gov</a>. This Court issued the Order Sealing those Exhibits.

#### II. ARGUMENT

Whether the Second Priority Payments are made is important to the Korean Claimants because of the Motion for Recognition and Enforcement of Mediation pending the Court.

Yeon Ho Kim, for the Korean Claimants, asked for the release of their respected Exhibits to Mrs. Karima Maloney, the counsel of the Finance Committee, and Mrs.Dianna Pendleton-Domingguez, a counsel of the Claimants' Advisory Committee, and Mrs.Deborah Greenspan, the counsel of Dow Corning Corporation and the Debtors' Representatives.

Mrs. Karima Maloney replied that she would address to the Parties. She did not reply to the second request though. Neither Mrs. Dianna Pendleton-Dominguez nor Mrs. Deborah Greenspan replied to the Yeon Ho Kim's emails.

The Exhibits must be available for the interested parties, including the Korean Claimants, to submit their opinions to the Court before the hearing set on March 23, 2017. The availability of the whole Exhibits is a part of due process.

#### III. CONCLUSION

Therefore, the Korean Claimants seek the Order that the Finance Committee release Exhibit B, and the Claimants' Advisory Committee release Exhibits 5,6,7,8 and 9, and Dow Corning Corporation and the Debtors' Representatives release Exhibits A, B to the Korean Claimants..
