Under the Notice Plan, the Notice will be sent to all individuals classified in Plan Classes 5, 6.1, and 6.2 who filed a timely proof of claim or notice of intent and who are not otherwise barred from participation in the distribution of settlement payments under the Plan. In addition, the SF-DCT will post deadline information on its website and will assist claimants with deadline questions via the telephone helpline. NOTICE PLAN OVERVIEW

Overview of Notice Plan:

- The Notice Plan consists of a single bulk mailing coupled with online postings and individual notifications contained in notification of status letters sent after review of claim submissions.
- The mailed notice consists of a concise one-page notice to be mailed the end of January 2018. Mailing in early 2018 allows sufficient time for claimants to prepare claim materials without creating anxiety or a "rush" that could overwhelm the SF-DCT. The mailed notice will have information in different languages advising claimants on how to obtain a translated version.
- The mailed notice contains information about how to access more detailed information online and how to obtain help via the helpline at the SF-DCT or by contacting the Claimants' Advisory Committee.
- Once the notice is mailed, the SF-DCT will begin sending revised notification of status letters that will also include deadline information.

Targeted Population:

- Estimated population: [143,000]. The mailing will be sent to the best available address for all Class 5, 6.1, and 6.2 claimants who filed timely POCs or NOIs except for those whose claims are barred.
- Barred claims are claims that cannot be processed in the SF-DCT such as claims that opted for litigation, claims that were withdrawn, and claims that have been permanently denied.
