**THIRD AGREED ORDER EXTENDING CERTAIN DEADLINES IN SCHEDULING
ORDER NO. 3 FOR CERTAIN DISPUTED LATE CLAIM REQUESTS (GROUP 1)**

On November 2, 2006, the Court issued Scheduling Order No. 3 for Certain Disputed Late Claim Requests (Group 1) (the "Scheduling Order"). On January 17 and February 16, 2007, the Court issue agreed orders extending certain deadlines in the Order. Upon the agreement of the Claimants' Advisory Committee ("CAC") and Dow Corning Corporation ("DCC"), it is hereby ORDERED as follows:

1. The deadline in paragraphs 4 and 5 of the Scheduling Order for the CAC and DCC to submit and serve their witness lists, exhibit lists, and exhibits is extended from March 30, 2007 to **June 8, 2007**.

2. The deadline in paragraph 6 of the Scheduling Order for additional witnesses and exhibits for Late Claimants is extended from April 13, 2007 to **June 22, 2007**.

3. The deadline in paragraph 7 of the Scheduling Order for the completion of discovery is extended from May 18, 2007 to **July 27, 2007**.

4. The final hearing date in paragraph 8(a) of the Scheduling Order for the following Late Claimants is extended from June 14, 2007 to **September 20, 2007 at 10:00 A.M.** Eastern Time:
