#### AFFIDAVIT OF PEGGY GERSTACKER IN SUPPORT OF DOW CORNING CORPORATION AND THE DEBTOR'S REPRESENTATIVES' RESPONSE TO MOTION OF CLAIMANTS' ADVISORY COMMITTEE FOR DECLARATORY RELIEF REGARDING RELEASES

BEFORE ME, the undersigned authority, personally appeared Peggy Gerstacker, who, after being duly sworn, deposed by me stated as follows:

- My name is Peggy Gerstacker. I am of sound mind, capable of making this 1. affidavit, and personally acquainted with the facts stated in this affidavit.
- I am currently employed at Dow Corning Corporation as a Corporate Site 2. Manager. I was the Manager of Implant Issue Operations from approximately June 1992 through May 1995.
- Implant Issue Operations was formed in response to the rising breast implant 3. controversy. The Implant Issue Operations included several informational programs and other resources available to breast implant recipients, their physicians, regulatory agencies, and members of the public. The different groups organized under Implant Issue Operations were as follows: Implant Information Center; Removal Assistance Program; Customer Relations Department; Complaint Investigation/Medical Device Reporting; and Medical Device

Investigation Laboratory. Implant Issue Operations reported to me for the time listed above and I never reported to the Legal Department.

- 4. Paulette Williams was promoted to a supervisor in the Implant Information Center in August 1991 and worked in that capacity until September 1992. In September 1992, she began working in the Customer Relations Department as a Senior Customer Relations Specialist.
- 5. I have reviewed the CAC's Memorandum In Support Of Motion Of Claimants' Advisory Committee For Declaratory Relief That The "Receipt And Release" Document Solicited By The Dow Corning Legal Department From Unrepresented Claimants From 1992-1995 As Part Of The Removal Assistance Program (Or Represented As Part Of Such Program) Is Not A General Release. The CAC discusses an "Implant Hotline Training" transcript from March 1992. In March 1992, Paulette Williams, who led the training documented in the transcript, was the supervisor of the Implant Information Center. Ms. Williams did not work in the separate Customer Relations Department at that time.
- 6. My notes indicate that Paulette Williams left Customer Relations at or around the end of March 1992.
- 7. Attached hereto as Exhibit A is a true and correct copy of a chart detailing the organizational structure of Implant Issue Operations dated February 21, 1994, which is a record kept by Dow Corning Corporation in the regular course of business, and it was the regular course of business of Dow Corning Corporation for an employee or representative of Dow Corning Corporation, with knowledge of the act, event, condition, opinion, or diagnosis, recorded to make the record or to transmit information to be included in that record; and the record was made at or near the time or reasonably soon thereafter.

Attached hereto as Exhibit B is a true and correct copy of a September 26, 1994 document containing the mission statement of the Complaint/MDR Team, which is a record kept by Dow Corning Corporation in the regular course of business, and it was the regular course of business of Dow Corning Corporation for an employee or representative of Dow Corning Corporation, with knowledge of the act, event, condition, opinion, or diagnosis, recorded to make the record or to transmit information to be included in that record; and the record was made at or near the time or reasonably soon thereafter.


